B. ADOPTION OF JOINT RESOLUTION OF THE CITIES OF JURUPA VALLEY, EASTVALE AND NORCO SUPPORTING UNDERGROUND TRANSMISSION LINES FOR THE PROPOSED RIVERSIDE TRANSMISSION RELIABILITY PROJECT NOW PENDING BEFORE THE CALIFORNIA PUBLIC UTILITIES COMMISSION (AT THE REQUEST OF MAYOR BRIAN BERKSON AND COUNCIL MEMBER CHRIS BARAJAS)


