NOTICE OF 30-DAY PUBLIC COMMENT PERIOD
AND PUBLIC HEARING TO BE HELD BY THE
CITY OF JURUPA VALLEY
REGARDING SUBMISSION OF THE 2018-2022 AND 2018-2019 ANNUAL ACTION PLAN**

NOTICE IS HEREBY GIVEN that the City of Jurupa Valley City Council will hold a public hearing and public comment period for the Action Plan for Fiscal Year 2018-2019. This action is taken in compliance with federal regulations [24 CFR 91].

As a recipient of Community Development Block Grant (CDBG) funds, the City is required to prepare a Consolidated Plan every five years. The City is also required to update the related Action Plan on an annual basis. The Consolidated Plan is a five-year strategic plan that identifies housing and community needs, strategies to address needs, and programs/resources to address these needs. The Action Plan delineates proposed activities to be funded under the U.S. Department of Housing and Urban Development's (HUD) CDBG program.

30-Day Public Comment Period

The required 30-day public comment period for the 2018-2022 Consolidated Plan and the 2018-2019 Annual Action Plan will commence May 8, 2018 and will end June 6, 2018. The draft document will be available for public review upon request at the public counter at Jurupa Valley City Hall – 8930 Limonite Avenue, Jurupa Valley, CA 92509. City hall is open Monday through Friday, 8 AM to 5 PM. The draft will also be posted on the City's website (www.jurupavalley.org). Written comments regarding the draft Consolidated Plan and Annual Action Plan may be submitted to the attention of Sean McGovern at the City Hall address. All written comments must be received by the City no later than 12 PM June 6, 2018.

2018-2019 Action Plan

The City will receive an allocation of \$1,189,419 in CDBG funds for Fiscal Year 2018-2019. The proposed use of CDBG funds includes the following:



▪ Program administration (including Fair Housing counseling)	\$217,020

The City is also required to hold a public hearing to obtain additional public comments regarding the draft 2018-2022 Consolidated Plan, 2018-2019 Annual Action Plan, and the draft Citizen Participation Plan. Notice is hereby given that the City of Jurupa Valley City Council will hold a public hearing on Thursday June 7, 2018, for this purpose. The hearing will be held in the City Council Chambers located at 8930 Limonite Avenue, Jurupa Valley. The City Council meeting will be held at 7:00 PM or soon thereafter. If you wish to challenge the City's decision in court, the challenge will be limited only to those issues you or someone else raised at the public hearing, prior to the public hearing, or in written correspondence delivered to the City Clerk's Department, prior to, the public hearing described in this notice.
