INDUSTRIAL SPECULATIVE BUILDING ON A 4.58 ACRES OF VACANT LAND LOCATED AT 5510 28TH STREET, JURUPA VALLEY (APN: 178-221-007)

Dianne Guevara, Deputy Community Development Director, informed the Commission that this item is to introduce the project to the Commission and receive feedback. COMMISSIONER DISCUSSION

- The Commission inquired about the types of businesses that are allowed in the Light Industrial zone.
- The Commission raised concerns of future third party companies occupying the building facility as a warehouse.
- The Commission stated since the CalEnviroScreen recognizes the area as a disadvantaged community the City should be proactive and request Community Benefits for the area such as requiring future tenants to give priority to City residents in applying for jobs and providing funding sources to purchase air filters to the adjacent residential area.
- The Commission requested that the City expand its outreach efforts to inform the residents of the proposed project.
- The Commission requested that the applicant reduce the number of loading docks from the proposed site plan.


