He outlined the process to define neighborhoods and communities of interest for the purpose of effective and fair representation. B. PUBLIC HEARING TO CONSIDER ZONING CODE AMENDMENT NO. 21006 (ZCA21006) REVISING REGULATIONS OF SECTION 9.240.490 (ALCOHOLIC BEVERAGE SALES) AND ADDING AN ANNUAL ALCOHOL SALE REGULATORY FEE TO THE CITY OF JURUPA VALLEY COMMUNITY DEVELOPMENT DEPARTMENT FEE SCHEDULE

Dianne Guevara, Deputy Director of Community Development, presented the staff report. Ms. Guevara reported on the negative impacts of alcohol sales in the community. She reported that on November 19, 2020, the City Council heard a presentation from the City Attorney on the City of El Cajon's ordinance. At that time, the City Council initiated a code amendment using the El Cajon ordinance as a template. Since that time, the Planning Commission held a study session and public hearing and recommended approval of the ordinance. Ms. Guevara described on-sale and off-sale alcohol sales and the amount of licenses per census tract. Ms. Guevara outlined the Council's recommendations and offered to answer any questions.

Further discussion followed.

Lieutenant Danny Young provided additional information and responded to Council's questions.

Mayor Barajas opened the public hearing.

There being no further comments, the public hearing was closed.

Following discussion, the Council provided feedback and suggested revisions to the proposed ordinance.

A motion was made by Mayor Lorena Barajas, seconded by Mayor Pro Tem Chris Barajas, to introduce Ordinance No. 2021-21, as amended as follows: 1) that the modifications described in the staff report would be included in the ordinance; and 2) with respect to on-sale alcohol uses, that they would be subject to the same inspection and the same performance standards as the offsale alcohol uses; entitled:
