### PLANNING COMMISSION

The five-member commission generally meets twice monthly to develop and review land use issues for the City of Jurupa Valley. The Planning Commission makes recommendations on these matters to the City Council. Members of the Planning Commission are appointed by the City Council. Each Council Member nominates one member of the Planning Commission which requires ratification by a majority of the City Council.

Each of the five commissioners shall be a resident of the City, a registered voter, and shall be appointed by and serve at the pleasure of the City Council.
